## PROFESSIONAL SERVICES

### **BASIS SERVICES OF FUNERAL DIRECTOR STAFF.....\$1,495.00**

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. **(This fee is already included in our charges for direct cremations, immediate burials, forwarding or receiving remains, and all funeral and cremation packages.)**

### **EMBALMING..... \$595.00**

(If you selected a funeral that may require embalming, such as a funeral with viewing, you may have to pay for embalming. You do not have to pay for embalming you did not approve if you selected arrangements such as a direct cremation or immediate burial.)

**DIRECT CREMATION.....\$1,050.00 to \$2,195.00**  
 Includes: Basic services of funeral director and staff, removal from place of death, transportation to and from crematory, cremation fee. “If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and may be made of materials like fiberboard or composition materials (with or without an outside covering.) Cremains will be returned in a durable plastic container.
